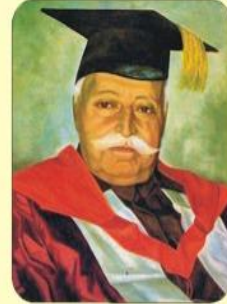

PREFECTURAL SYSTEM

“Leaders are not born but are made by their experiences in life”. To inculcate the leadership qualities in the students and to give them a feel of functioning of the administrative body, School Cabinet members are selected every year after scrupulous interviewing and selection. through a formal investiture ceremony. The objective behind the student council is to inculcate leadership qualities and team spirit through real time practice. Through such practices the students learn to take up responsibility for their school and fellow mates and learn important life lessons.

AUDITORIUM

Our school promotes new avenues for the all-round development of the students. An important and critical feature of our school’s facilities is the auditorium. This grand hall has been the center stage for a number of our students who have proved their mettle in dramatics, debates, musicals and other talent shows. The auditorium has been the battle-field of several inter-school competitions and has seen hundreds of students showcase their finest talents.

CONFERENCE ROOM

The school has a fully air-conditioned and equipped conference room, with the latest and the most sophisticated audiovisual equipment, to make the meetings, PTA's sessions and workshops, more collaborative and connected.



ADMISSION PROCEDURE

1. Dyal Singh Public School is open for admission to boys and girls irrespective of their caste and social status.
2. The school opens registration and admission for classes Pre-Primary and XI from January every year.
3. Registration Forms are available at the school counter on payment of prescribed fee.
4. Registration does not guarantee admission. New admission for other classes is made subject to the availability of vacancies in each class in the month of March after the declaration of the annual results.
5. A Candidate seeking admission to classes other than Pre-Primary classes must bring a Photostat copy, school leaving certificate from the school last attended along the progress report and character certificate.
6. A student seeking admission to Pre Primary classes must bring a Photostat copy of municipal birth certificate and Aadhar Card. The date of birth entered at the time of admission will be altered.
7. If a child is found fit for admission, the guardians/ parents must deposit the prescribed dues and other funds in time.
8. if a parent /guardian decided not to send his ward to school after the fee has been deposited, the amount deposited will be returned as per CBSE/ School rules within a month.
9. The admission to 10 + 1 is provisional; subject to his passing the tenth std. examination. The student will have to be withdrawn from the school in case he/she fails in class X examination or gets compartment even if he/she has paid the fees and /or has attended the classes. In this case fee will be refunded.

PAYMENT OF FEES

Fees is to be deposited in the Bank, by the 10th of every quarter. The students newly admitted in the school will pay the fee for April - June at the time of admission. In the interest of the parents, it is advisable to pay the fee in time.

Other Terms and Conditions Regarding Fee: -

1. Refund of student security should be claimed within three years of leaving the school. After three years the security will lapse.
2. Fee book must be retained for income tax rebate. No separate certificate rebate will be issued.

PROCEDURE FOR WITHDRAWAL

1. Prior to the withdrawal of a student from the school, a month's notice or the payment of a month's fee in lieu of notice is required.
2. The Principal can ask a student to withdraw from school on and one of the following grounds:
 - (a) Constant continuous poor performance in studies.
 - (b) Irregularity in attendance
 - (c) Indiscipline
 - (d) Non-payment of the fee or irregularity in payment
3. No school leaving certificate is issued without a written application from the parent/guardian. All school dues must be cleared before applying for the certificate.

TRANSFERS

Parents of students withdrawing from school should contact the office at least one month prior to the last day of attendance. This allows time for completion of records, returns of books. All accounts with the school should be settled prior to the transfer.

DRESS CODE

The school uniform is of vital importance to the students. It encourages simplicity, group living, cleanliness and a feeling of equality. Therefore, students will come to school in the prescribed uniform only.

SUMMER

Boys: Light blue checkered half-sleeves shirt with a collar, navy blue shorts trousers Upto VII and navy blue trousers for classes VIII to XII, navy blue socks, black shoes, school belts and school badge.

Girls : Light blue checkered blouse with half-sleeves and collar, navy blue skirt/tunic & necktie, navy blue socks, black shoes, school belts and school badge.

Light blue checkered salwar kameez for classes IX onwards.

Sikh Students

- (i) Blue Patkas Class VIII and below
- (ii) Blue Turbans Class IX and onwards

SECURITY

A safe and secure environment is a prerequisite for effective teaching and learning. Keeping in view, the security and safety of the children in school premises, entire school campus, including, classes, labs, Auditorium, Corridors and buses are under CCTV surveillance.

All Assembly Days During Summer

Boys : House T-Shirts, White trousers / shorts, school belt, white canvas shoes and white socks.

WINTER

Boys : Full sleeve light blue checkered shirt (with collar), navy blue pants, navy blue pullover and blazer, navy blue socks, black shoes, school badge, belt and tie.

Class Nursery to II: Navy blue T-shirt, blue, red and white checkered jacket, navy blue lower, black shoes, navy blue socks, school badge, belt and tie for girls and boys both.

Class III to VIII : Full sleeves light blue checkered shirt (with collar), navy blue tunic/skirt, navy blue pullover and blazer, navy blue socks, black shoes, school badge, belt and tie for girls.

Class IX onwards : Light blue checkered salwar kameez, navy blue pullover and blazer, navy blue socks, black shoes and school badge.

INCLEMENT WEATHER / SCHOOL CLOSSING/ MAKE-UP SCHEDULE

In the interest of students' safety, a decision to close, delay or dismiss school early due to inclement weather can be taken. Parents will be notified via phone and/or e-mail/SMS about such decisions.

EARLY DISMISSAL / LEAVING SCHOOL GROUNDS

When Leaving school prior to dismissal students must report to the office to be signed out by a parent / guardian designates. This requirement is to ensure the safety and well-being of your child.
